
Terms and Conditions:

1. The appointment will be on contractual basis. The tenure of the position will be initially for one year and likely to be extended after a review every year subjected to maximum of 03 years.
2. This appointment is purely temporary and can be terminated by giving one month notice from the employer or employee without assigning any reason.
3. In case, your services or conduct or both are not found to be satisfactory, the Project assignment can be terminated at any time without giving any notice.
4. He / She will have no claim for any regular or permanent appointment in the RSC as this appointment is purely temporary time bound arrangement.
5. JRFs will be paid only the consolidated amount Rs. 25000/- fixed per month. No other allowances will be paid.
6. The Junior Research Fellow will be entitled for TA/DA, Casual Leave and Optional Leave as per RSC existing rules. They will not be entitled for any other leave.
7. Selected JRF can be sent on tours anywhere in the Country for outdoor scientific activities of the Science Centre.
8. The candidate may be assigned other work as per requirement in the Section / Wing/ Office of the Chhattisgarh Regional Science Centre, Raipur by the Project Director. The discretion of the same remains with the Project Director on approval of Director General.
